

## Influencing and changing policy





- ACT works with the Lake District National Park (LDNP) Partnership and Zero Carbon Cumbria on carbon reduction, sustainable transport and rural living.
- We held an online conference with 100 participants, discussing appetite for different travel options for locals, businesses and visitors in the Lake District
- We've worked with ACRE to lobby on and influence banking policies in rural areas, highlighting the importance of access to banking services



## Influencing and changing policy



We hosted a successful and engaging visit from 60 University of Liverpool students, keen to expand their knowledge of rural issues, specifically around spatial planning, access to services and social care in rural places.

## Planning for the future





- ACT was commissioned to run a Housing Needs Survey for Arnside Parish Council, to inform their plan for future housing. There is interest in taking a community led approach to providing a small number of affordable homes
- ACT continues to work with Silloth Town Council on their Town Plan. Four online consultations have identified priorities for the area
- We assisted 12 community buildings to have energy and building condition surveys which helps them plan for a sustainable future




## Planning for the future



- With funding from Electricity North West, we've provided wraparound support to 35 communities affected by Storm Arwen.
- In partnership with Cumbria Community Foundation, community venues and emergency response groups have been able to purchase resilience equipment.
- We've link groups up with Cumbria Local Resilience Forum and provided advice on emergency planning

'A huge thank you to the team for the support to apply for funding and purchase three emergency generators which have been installed in Alston, Garrigill and Nenthead to support the community in extraordinary events'





## Supporting project development





- Our first face to face community buildings (CB) event since the pandemic started was a great success, with discussions on project development
- ACT supported 25 CB projects towards achieving National Lottery funding.
   Five halls were awarded Hallmark quality standard certificates
- We facilitate volunteer collaboration meetings amongst Eden's five community run open air swimming pools

## Working with others



ACT assists communities to make their voices heard and to advocate for change

- We worked with partners in the county to produce a toolkit to help over 200 venues set up 'Warm Spots'
- Warm spots provide at least four hours of free, welcoming, neighbourly activities and refreshments each week
- We assisted with policies, procedures, funding and advice
- We worked with Copeland Community
  Fund to develop eight rural warm spots
  in response to the cost of living crisis





## Working with others





- Working with the Environment Agency, ACT has supported active community members and representatives to have a place at the table with the Love Windermere Partnership which is developing a 25 year plan for the catchment
- Working with the LDNP Partnership we are helping to tackle some of the most intractable challenges in how we balance the interests and needs of both communities and visitors in the Lake District
- The Esmee Fairbairn funded Collaboration Hub is enabling us to support communities in creative and innovative ways


