# ACT Champions Community and Rural Issues:

#### Cumbria Rural Forum

Is the Forum for discussing rural issues, sharing best practice and taking action in Cumbria. The Forum is facilitated by ACT and managed by representatives of the Forum membership. Chairperson Ian Soane says "The Forum is successful due to the high quality and range of presenters, and good participation of members. This year focussed on a range of issues affecting those in poverty in rural areas."

#### Impact of Welfare Reform upon Financial Inclusion

A joint event with the Cumbria Financial Inclusion Forum, supported by Derwent and Solway Housing, this provided an opportunity for those working in the area of welfare to share their concerns about how welfare benefit changes may affect vulnerable people across Cumbria. 40% of income deprived people, housing and council tax benefit claimants, social housing tenants and incapacity benefit claimants in Cumbria live in rural communities.

Participants concluded that the overall effect of the changes could be to undermine the sustainability of rural services and facilities, making it yet more difficult to maintain balanced or socially sustainable rural communities. This issue will be revisited in 2014.

#### **How Rural Communities Address Energy Costs**

This event focused on what individuals can do to save money in the face of rising fuel costs, and encourage discussion of the issue in their community. Rising fuel costs is of particular concern to rural residents because of their greater reliance on expensive, off-mains fuels.

From the presentations and workshops delegates recorded many discussion points and advice to take back to their communities:

- Conserve energy first, using simple steps, insulation and draught proofing, making better use of heating controls and turn off stand-by appliances.
- 500 jobs would be created if Cumbria's woodland were to be properly managed.
- There is scope to promote energy efficiency and the bulk purchasing of wood and oil at community level.
- Over 80% of homes have never switched energy supplier. In many cases switching will save money.

# **Emergency Planning**

The Cumbrian floods of 2009 were, for many individuals and communities, a life changing event. No longer could such extreme events be pigeonholed as 'rare' and only happening to somebody else. One important response was the development of a Community Emergency Planning toolkit by ACT and partners which asks the question: 'How would my community survive the first 48 hours of a serious emergency?' and provides a method that any community can follow to help them prepare for emergencies.

The Ten Step Community Emergency Plan distills current Cabinet Office and Cumbria County Council guidance. We are indebted to the work of the Keswick Flood Action Group, and the field-testing of the resource by Melbreak Communities (Lorton, Blindbothel, Loweswater and Buttermere). Throughout, the work was supported by the newly formed Community Resilience sub group linked to the Cumbria Resilience Forum, and co-chaired by ACT.

The Ten Step Community Emergency Plan was launched at a 'Power for Change' conference in May 2012 and is available on the ACT and County Council websites.

# **Community Planning**

Assisting communities to make the localism agenda real, ACT has continued to support them in producing Community Led Plans (CLPS). This is a step by step process that can empower communities to take action to improve their areas. ACT offers a range of services to those developing CLPs including guidance sheets and other resources, workshops, grant funds and advice by phone and email.

In the past year we have focused on reviewing and improving CLP resources and have obtained funding from Eden and South Lakeland district councils to establish CLP grant funds in those districts. We have also delivered training to councillors in Eden and South Lakeland.

A number of communities in Cumbria are producing Neighbourhood Plans, which focus on land use planning, and others are exploring whether this is the right option for them. ACT has been helping communities to understand the difference between Neighbourhood Plans and Community Led Plans when making the decision to start either type of Plan. There are over 100 Cumbrian CLPs, all available on our website.

# Tebay & Orton Local Distinctiveness

This three year project, funded by the Rural Development Programme for England and coordinated by ACT has now come to an end. The aims of the project were to provide training and facilitate events for the communities of Tebay and Orton Parishes, to raise awareness of, and pride in, the cultural heritage of the area.

#### **Project Achievements:**

- · Boost to local pride and knowledge.
- Local tourism businesses supported and strengthened through networking opportunities and the production of marketing materials.
- Supported the Friends of Tebay Church group to develop a new community facility (The Hub) in the church vestry, and a church heritage guide.
- Development of the Lunesdale Archaeology Society; training for members; heritage days with archaeological digs at the Roman Fort, Low Borrowbridge Farm; and education materials for Tebay Primary School.
- Written and video case studies and guidance sheets, also available on the ACT website.

# **Grants and Project Support**

#### **Health and Wellbeing Programme**

This year saw the start of the Community Health and Wellbeing programme, covering Eden and the Keswick area. It provides support for community groups to develop sustainable projects which improve health and wellbeing in their areas. ACT provides support to the groups to develop and monitor their projects and apply for a grant fund administered by Cumbria Community Foundation. This project is funded by Cumbria County Council Adult Social Care and Cumbria Clinical Commissioning Group.

#### **BASIS**

ACT has supported community groups and village hall committees to improve their governance by understanding and updating their governing documents. Business planning advice has supported communities to develop their projects, and groups have also been given practical advice and support to obtain funding. Delegates from village hall committees attended training to focus on trustee roles and responsibilities and share best practice on running a community building effectively.

# Whole Valley Planning

Whole Valley Planning, was initiated by ACT and partners in Borrowdale following the devastating floods of 2009. Another community-based valley planning initiative, prompted by extreme visitor management and car parking challenges, began in Wasdale in 2012. Here, the approach was similar to Borrowdale, with ACT mediating community and agency planning. In Wasdale, a development plan for the valley was commissioned which offers opportunities for collaborative working for the next 5 – 10 years.

Ullswater was selected to be a full pilot for this approach in 2012. The first gathering took place in February 2013, attended by 82 residents and agency support officers. Eight key areas of work were identified including: Management of the Environment – maintaining the balance; Water – A common-sense approach; Employment & Economy – employment-led sustainable development; and Heritage – Ullswater heritage is special and needs to be protected, developed where appropriate, and communicated more widely.

Our partner the Lake District National Park is continuing this work with the local communities in these areas.

# Credit Unions – supporting rural communities with financial accessibility

Credit Unions are locally managed by and for their members. They provide secure savings, affordable loans and free life insurance. To their members they offer a safe place to save, and an affordable place to borrow

ACT ran a Seminar with the Cumbria Rural Forum Business Group, the six Credit Unions and two study groups serving the people of Cumbria. The Seminar looked at good practice in reaching rural residents, including increased collaboration with others working in rural areas and widening the availability of online services.

Credit Unions are promoting their services through Schools, Churches Together in Cumbria, MP's and local councillors. Local word of mouth is also very important. Cumbria Rural Forum and ACT Members and Supporters are encouraged to promote Credit Union services in their community. 

# **Neighbourhood Planning**

The Localism Act 2011 introduced statutory
Neighbourhood Planning in England. The Act enables
communities to draw up a Neighbourhood Plan for their
area and is intended to give local people more of a say in
the development of their community.

In order to reduce confusion in communities about Neighbourhood Planning, ACT produced guidance, in partnership with CALC, setting out the differences between Neighbourhood Planning and Community Led Planning and how the two can fit together.

It also provides a step by step guide to developing a Neighbourhood Plan. 'Planning for your community's future in Cumbria' is available on the ACT website.

The guidance has been endorsed and welcomed by planning authorities across Cumbria and forms part of ACT's work with the Lake District National Park Partnership where ACT and CALC lead on the Vibrant Communities strand of the Partnership Plan.

# Community Transport Roadshow

ACT and the Cumbria Community Transport Forum (CCTF) highlighted a range of Cumbrian Community Transport solutions at this national Community Transport event in Carlisle. Communities were encouraged to build on existing schemes such as these to address rural transport issues:

- Cumbria County Council Voluntary Car Schemes, Rural Wheels, and new minibus programmes in each district.
- Cumbria Community Transport Project countywide brokerage scheme.
- Fellrunner Buses 15 years service in Eden.
- The Northern Fells Minibus running alongside other community support services.

A number of challenges were also identified such as: recruiting younger people, both as volunteers and passengers; the technical and legal challenges for volunteers involved in transport; reduced funding; and the need for more publicity for existing schemes.

ACT will continue to work with CCTF, supporting them to influence and deliver community transport in Cumbria. More information is available on the ACT website.

#### Resources for Communities



Various ACT resources

ACT is continually looking at ways of delivering effective support to communities. Over the years we have developed a wide range of resources including Guidance Sheets, Toolkits, Workbooks, and both written and video Case Studies, to share best practice and useful information. These cover a range of subjects including:

- Community Led Planning, Neighbourhood Planning Emergency Planning etc.
- Effectively running a community building.
- Getting started, setting up a new group, choosing a structure and other governance issues.
- Community Exchanges, Local Distinctiveness projects, Community Energy projects etc.

Through our national umbrella body, Action with Communities in Rural England (ACRE), ACT also has access to a wide range of additional resources, including detailed Village Halls Information Sheets. We also signpost to specialist advice from other organisations such as governance information and model documents from the Charity Commission.

- April 2013: Launch universal, free advice service.
   Any enquiry to ACT will receive a dedicated response, including referral if appropriate.
- July 2013: Launch new ACT Website. This will provide easier access to the large range of resources and examples of activities communities across Cumbria have undertaken.
- Sept 2013: Monthly rural engagement events, an opportunity for communities and agencies to

- Autumn 2013: Launch "State of Cumbria" Report. This will detail, with statistics, challenges and opportunities for Cumbrian rural communities.

We also hope to affect the delivery of the Rural Growth Network, work with rural surgeries on maintaining services and promote the DEFRA Rural Proofing Guidelines.


# Finance Report

Against the backdrop of limited resources and uncertainties over funding, underpinned by the national economic recession, it has continued to be difficult to plan or develop services. The year has been very challenging and resulted in a small deficit of £7266 for the 2012/13 financial year. Trustees, managers and staff continue to work to establish robust plans for the future of the organisation and to provide it with a diverse income base that will support continued activity appropriate to the Charity's objects.


